







What to bring to enrolment checklist

We want to ensure that your enrolment experience runs as smoothly and as quickly as possible.

In order to achieve this, we need you to bring the following documents / information.

Please use this checklist to gather together all the information you need to bring, when you come to enrol. Failure to provide the correct documentation, could delay your enrolment.

For Childcare and Health & Social Care, DBS evidence and 3 forms of ID are also mandatory (see table on page 2 in red)

- Biometric Residency Permit

List B - TWO Documents

- •National Insurance Letter
- Bank statement / Mortgage Statement dated within 3 months
- P45 / P60
- Utility Bill in students name dated within 3 months
- PIP letter in students name dated within 6 months
- Letter from head teacher at last school dated within 3 months
- National proof of age card (must carry the PASS logo)
- Marriage certificate
- Any Government letter addressed to the Student issued within last 12 months
- HM Forces ID card
